Today, all these years later, she still has that job. She still keeps in touch with her CASA. And her daughter?

Her daughter is attending SOU.

This is why we do what we do. Because sometimes, the steady presence of one caring adult can change the course of a life—and, in this case, two.

HAPPY ENDINGS



We love to share celebrated success stories of happy endings, especially happy endings directly attributed to the dedication and devotion of a CASA volunteer! This is the story of two siblings, now age seven and three, coping with years of living in a meth-house, domestic violence and foster care.

As required by Oregon State law, DHS did everything they could to reunify the family over the years, working with community partners to heal the family unit and placing

the children with family friends when on and off parental chaos that often accompanies drug addiction occurred. During the process, two years passed by. Then CASA Robert stepped into the picture. Within 15 months, the children were adopted by close family friends, stepping into a safe, healthy permanency.

This story exemplifies why there are CASA's assigned to cases, providing another pair of trained eyes collecting and reporting information, facilitating services, advocating in court. This is a unique service opportunity because CASA's go one-on-one with the child, one child at a time. It is not a job for everyone. As we often say, "We're looking for tough softies."

Today there are over 200 "tough softies" on the job in Jackson County – we appreciate and celebrate each one of them.
